



Our Impact Work



Decent Work and Economic Growth

(UNSDG 8)

We are committed to taking our responsibilities as a socially conscious law firm seriously for the long-term. Our impact aims include: supporting staff and suppliers to do more, using our knowledge and skills to help others to do more than alone, creating a culture of inclusivity and diversity, and looking after the world around us. Using a definition from the Social Purpose Institute, 30% of matters in 24/25 were for clients with a social purpose.

WE DO THIS BY:

- **Providing expertise and advice** to start-ups and innovators at Imperial Enterprise Lab, Oxford Saïd Business School, London Business School and University of Manchester's Global Graduates Programme.
- **Giving staff time to volunteer** for social causes from suicide prevention charity The Listening Place, hospice care charity Pilgrims Hospice, Torbay Hospital Radio, Odiham Cricket Club, Derwenlas Community Centre and refugee charity, West London Welcome.
- **Providing pro and lo-bono work** for organisations such as Torbay Hospital Radio and West London Welcome.
- **Provide 30 minute advice surgeries** for charities free of charge.
- **Offer flexible working and policies** such as 14 weeks full paid maternity leave, adoption and shared parental leave pay, and diversity training.
- **Supporting employee wellbeing** with policies such as, breastfeeding policy, transgender policy and menopause policy, team yoga and socials every week. We regularly check-in with staff to manage workload and wellbeing and undertake an annual staff happiness engagement survey.
- **Offering hybrid working** allowing our employees to work 50% of their work time at the office over a two-week period, and one week per year from anywhere in the world they want.
- **Providing private healthcare and insurance** to all employees along with life assurance that is worth three times an individual's salary. We have pensions with an ethical investment option (Nest).
- **Publishing short video interviews** with our staff on our social media channels.
- **Providing a real Living Wage** ensuring that all our employees receive a real Living Wage in line with the guidelines of the Living Wage Foundation.

Tackling the Climate Crisis



- **Being a certified member of Green Small Business** that allows us to track and report our environmental impact, improve our efficiency and reduce costs.
- **Regularly monitoring and recording** of our waste production.
- **Providing advice to our team** to help them reduce their environmental impact whilst working at home.
- **Using an active Environmental Action Plan** that monitors, reviews and provides advice on areas such as energy consumption in the office, recycling, waste disposal, green travel, purchasing of sustainable goods and services, providing green advice to clients and ethical company administration.
- **Being members of 1% for the Planet** and giving support to environmental organisations.

PONTERRA



We have advised Ponterra, our long-standing client focused on global nature restoration projects, across a range of corporate legal matters. Ponterra is a commercial developer and operator of biodiversity-rich reforestation projects with a mission to restore nature at scale. They develop the highest-quality carbon projects that not only reverse climate change but also bring back biodiversity and uplift rural communities. Ponterra's flagship project in Panama is fully financed by Microsoft and Rubicon Carbon and will restore 10,000 hectares of degraded agricultural land by planting over 75 native tree species in partnership with smallholder farmers.


CASE STUDY


WE DO THIS BY:

- **Supporting organisations** such as Torbay Hospital Radio, and West London Welcome, a community centre that supports refugees, asylum seekers and migrants from across the world.
- **Volunteering with The Listening Place**, a mental health charity that provides support to people who are dealing with issues of suicide, LawCare, that provides peer to peer support to lawyers, Derwenlas Community Centre, and Refugee Network International, that provides vital food and suppliers to homeless refugees in London.
- **Donating to charities** such as GoodGym, Borneo Orangutan Survival UK, The Childhood Trust, City of Trees and Environmental Investigation Agency UK.

Sunny Hill Foundation, founded by global music artist Dua Lipa, is a charity dedicated to supporting Kosovan society through arts and culture initiatives. Its annual event, the Sunny Hill Festival in Pristina, has featured major artists including Fatboy Slim, Shawn Mendes, and Stormzy. The Foundation also empowers emerging songwriters and musicians via industry collaborations and scholarships for young women in STEM, and supports local community organisations. As part of its work in the music sector, London Law Collective co-founder David Farquharson serves on the Foundation's Board, providing commercial and charity law advice.



Shockingly nearly 12,000 people sleep rough in London every night. Food, hygiene, digital and clothing poverty are just some of the things that rough sleepers, the homeless and marginalised communities suffer daily. For many, just getting their hands on the essentials needed to survive is a daily struggle.

That's where Refuge Network International come in. Their mission is simple, to bring communities together to effect change and leverage corporate power to empower communities. Working with partners, volunteers and supporters they strive to improve the lives of those who need help, directly. They do that by providing lifesaving meals to people on the streets, providing essential items such as toiletries, clothing and bags and providing support to refugees, migrants and the homeless.

That's also why the London Law Collective team volunteered with Refuge Network International to deliver a lunch service at an outdoor soup kitchen and hand out food parcels to rough sleepers in Central London. This was a very rewarding day for the team but also allowed us to see first-hand the impact we can have together on the lives of people who need it.
